



3. To remain vigilant on the happenings /events related to Ragging in Campus or Off-campus and other designed places in the premises.
4. To conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incident of Ragging, and considering such other relevant information as may be required.
5. To monitor, direct and oversee the functions and performance of the Anti-Ragging Squads in prevention and curbing the menace of ragging in the institution.
6. To organize counseling sessions for seniors and fresher's separately to sensitize about the serious draw backs and legal consequences of Ragging and to invite a support to prevent ragging.
